

Academic Course Progress Policy (International Student)

POLICY PURPOSE

This policy sets out the principles and supporting practices that UTS College follows to ensure we meet the Standard 8 of The National Code 2018; whereby UTS College must monitor students' academic progress, implement intervention strategies to assist students at risk of failing to meet course progress requirements and report international students who do not achieve satisfactory academic progress to the Department of Home Affairs.

SCOPE

This policy applies to:

All students on student visas, enrolled in UTS College academic courses (including the UTS Foundation Studies program, which are offered by UTS College on behalf of UTS, Cambridge International AS and A Level Program, the Diploma and Graduate Certificate courses offered by UTS College).

This policy also applies to all staff involved in the management and reporting of UTS College students' academic progress.

This policy **does not** apply to UTS College domestic students, or students on other types of non-student visas (e.g., a tourist or working holiday visa).

DEFINITIONS are set out at the end of this policy.

POLICY PRINCIPLES

Principle

Academic progress is monitored and recorded

- 1. UTS College assesses, monitors, and records students' progress throughout each study period and academic results on completion of each subject and at the end of each study period.
- 2. UTS College monitors the progress of students to always ensure that students can complete the course in the time as specified on their CoE
- 3. Students are expected to monitor their own progress throughout their studies

Principle

Identify students at risk of unsatisfactory academic course progress

- 4. Students are sent an Academic Course Progress Policy (International) reminder letter as soon as it is identified that they are 'at risk' of not achieving satisfactory academic course progress.
- 5. Students are sent an Academic Course Progress Policy (International) warning letter when they are deemed at 'high risk' of not achieving satisfactory academic progress.

Student Support

- 6. UTS College provides Individual Education Access and Inclusion Plans for students who are eligible for reasonable adjustments under the Education and Access Equity Policy.
- 7. Learning support and other forms of support will be made available to students at risk of not achieving satisfactory academic course progress.
- 8. Intervention strategies are implemented once a student is identified as being 'at risk' of not achieving satisfactory academic progress and are tailored to meet each student's individual needs.
- 9. Intervention strategies may include but are not limited to:
 - Regular meetings with teachers / Student Success Advisers for study assistance
 - Support with implementing effective study strategies and time management skills
 - Granting of Special Consideration in circumstances of serious illness or misadventure, which has affected the student's ability to submit or sit for assessments.
 - Adding to the Access Inclusion register and developing of Individual Access and Inclusion Plan if student's needs comply with Education Access Inclusion policy
 - Accessing learning support at UTS College
 - Reducing course load (if before census date academic students can be advised to drop subjects)
 - Accessing counselling support
 - Referring to any other support services if and when required.
 - A combination of the above

10. Early identification of students at risk occurs in the first five weeks of each study period.

- 11. Teachers and Student Success Advisers work with at risk students to implement appropriate intervention strategies.
- 12. Students who are identified as being 'at high risk' will also be placed on an Academic Success Program for the following study period and will be required to meet the conditions as set out in the Academic Success Agreement to improve their academic performance.
- 13. Students are provided with equivalent opportunities for successful academic course progress, irrespective of their backgrounds.

	UTS College will only extend the duration of enrolment in a course Under Compassionate or Compelling Circumstances, when it is clear the student will not be able to complete by the end date of the CoE.

	UTS College will provide relevant documentation to the student should an extension be granted. Students will be advised to contact the Department of Home Affairs to seek advice on potential impacts on their visa, including the need to obtain a new visa.		
Report	ing to the Department of Home Affairs		
	Students who are identified as having unsatisfactory academic progress will be issued with an Intention to Report Letter outlining that they have 20 working days to access UTS College's Student Complaints and Appeals policy.		
	Students who are not accessing the appeal process or are unsuccessful with the appeal will be reported to the Department of Home Affairs.		
	Once a student is reported, the student will be excluded from UTS College. Students who are excluded are not permitted to re- enrol in any UTS College course for 2 years.

Academic Success Agreement	An Academic Success Agreement is made between a 'high risk' student and their Student Success Adviser and details specific performance improvement conditions and initiatives which a student must meet. See "At High Risk".
Academic Success Program	An Academic Success Program is an agreed plan of intervention strategies put in place by a Student Success Adviser to help improve

Academic Student	Student enrolled in the UTS Foundation Studies program, offered by UTS College on behalf of UTS, Cambridge International AS and A Level Program, Diploma and Graduate Certificate courses offered by UTS College.
At Risk	Students who fail an assessment in any given study period are deemed to be at risk of not meeting UTS College academic course progression requirements. For Cambridge International AS and A Level Program, students who scored a grade with E or U with an assessment in any given study period except summer semester are deemed to be at risk of not meeting UTS College academic course progression requirements.
At High Risk	Students who fail over 50% of their subjects in any study period, or students who fail any subject for a second time, are deemed to be at high risk of not meeting UTS College academic course progression requirements. For Cambridge International AS and A Level Program, students who scored a final grade with E or U for over 50% of their subjects in any given study period except summer semester are deemed to be at high risk of not meeting UTS College academic course progression requirements.
CoE	Confirmation of Enrolment (CoE) - A document provided electronically, which is issued by UTS College to intending international students and which must accompany their application for a student visa. It confirms the international student's eligibility to enrol in a particular program.
Compassionate or compelling circumstances	 Compassionate or compelling circumstances' are those beyond the control of the student that have an impact upon the student's course progress or wellbeing. These could include, but are not limited to: serious illness or injury, where a medical certificate states that the student was unable to attend classes; or bereavement of close family members such as parents or grandparents; or major political upheaval or natural disaster in the home country requiring emergency travel and this has impacted on the student's studies; or a traumatic experience which could include involvement in, or witnessing of a serious accident; and witnessing or being the victim of a serious crime and this has impacted on the student (these cases should be supported by police or psychologists' reports); or Any other circumstance would require evidence to be considered as compassionate or compelling.
Course	The term "course" is used throughout this document to refer to UTS Foundation Studies courses, Cambridge International AS and A Level Program courses, UTS College Diploma and Graduate Certificate courses.
