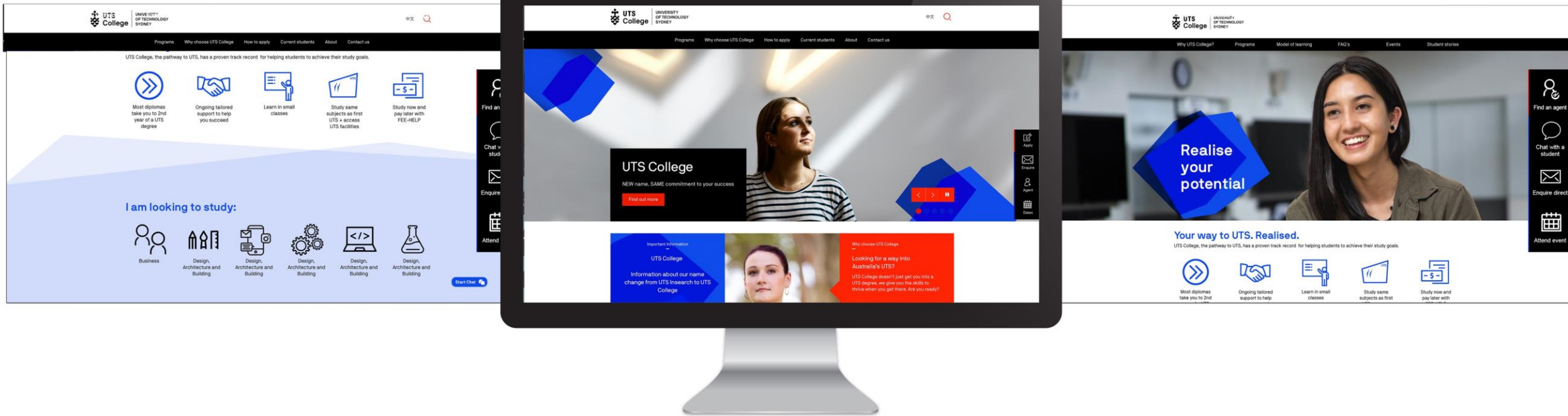

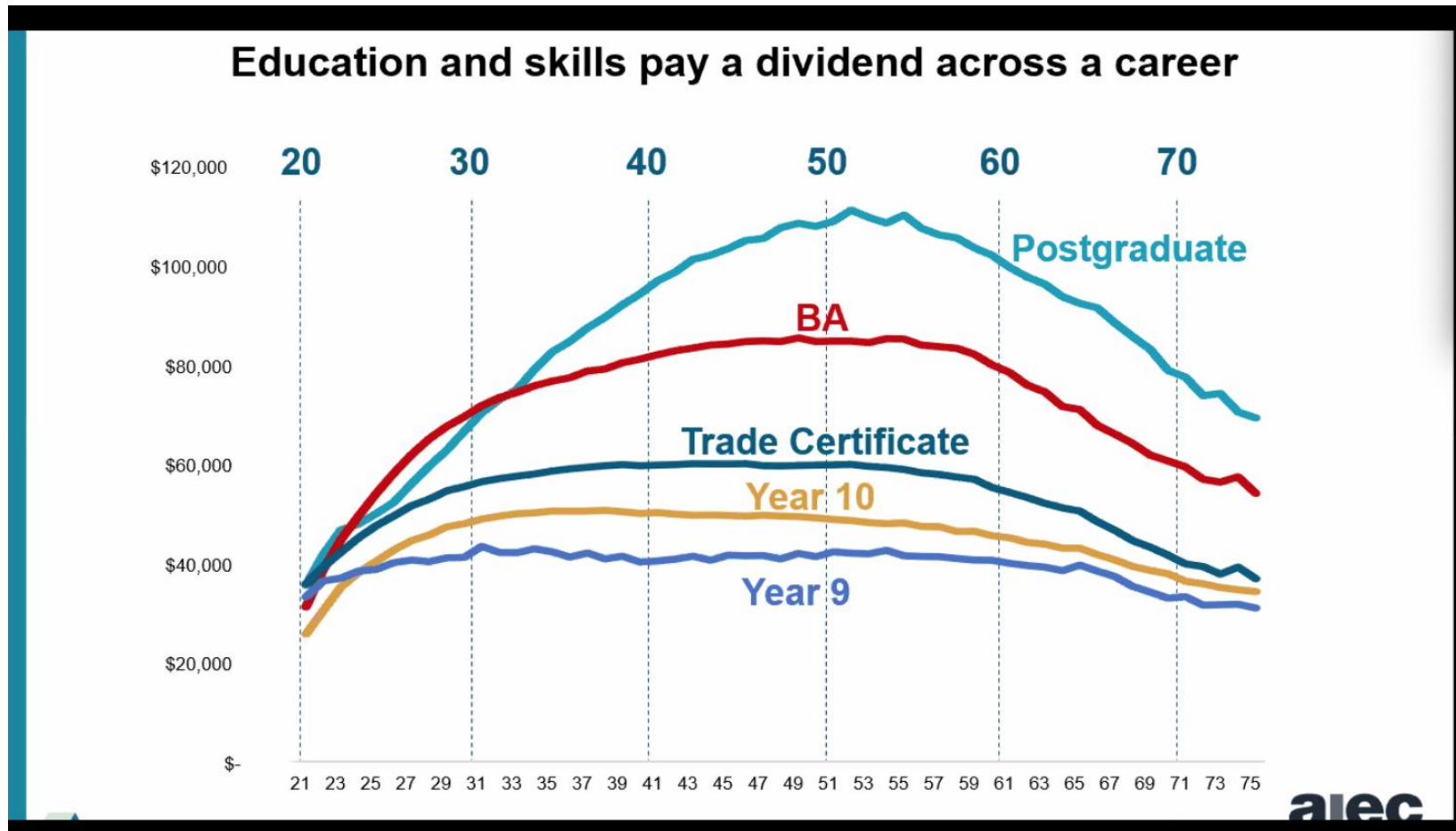

What is the difference?

UTS College Pre-Master's Programs	IELTS 6.0 with 6.0 in writing	Associate Degree (AQF 6)



Who are we targeting

1. Quality students from around the world where their Bachelor degree is not recognised by Australia or
2. Students that have met academic entry for the Masters but lack the English requirement (6.5 IELTS) for entry to UTS

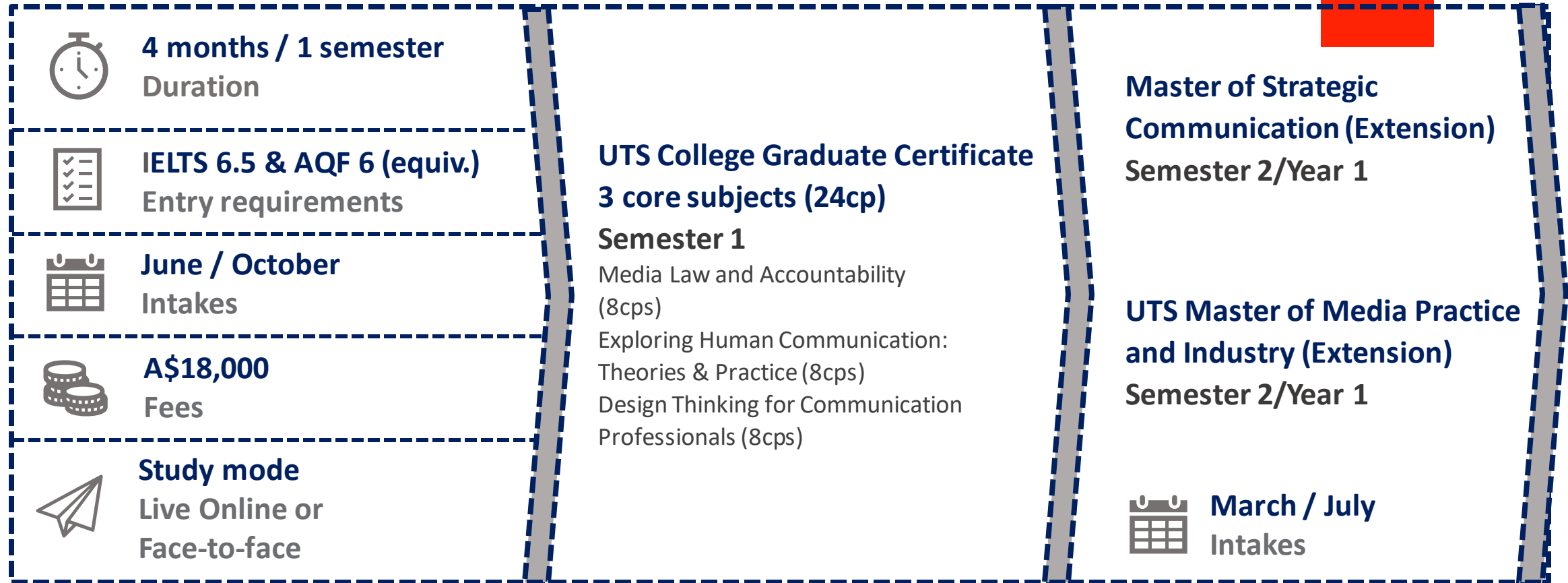
Accounting and Finance Accelerated program



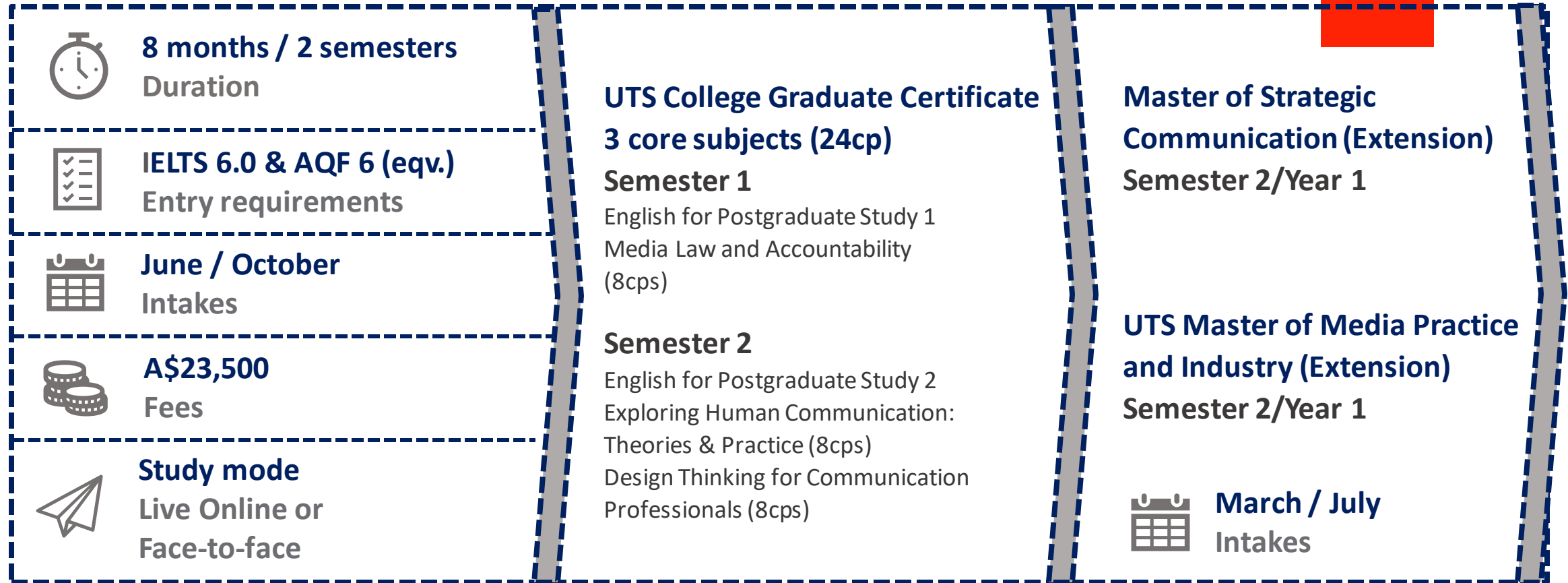
Accounting and Finance Standard program



Communication Accelerated program

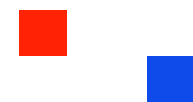
